What to do if ICE Comes to Your Farm

Do you have a lawyer that you can reach out to, at least during business hours that knows you and will help you out? Is the phone number on your phone? One of the seminars I attended recently in Nebraska discussed ICE raids on a business. I took home three main points.

First, you don't want to be looking on Google for a local law firm if ICE shows up. Do a little planning, contact a lawyer, make sure the lawyer or law firm is willing to help if there is an ICE visit to your farm, and get their OK.

Second, if ICE shows up on your farm, stop and take a deep breath. Ask to see the warrant, take a picture, and see if it is signed by a judge. There are two kinds of warrants, a judicial warrant and an administrative warrant. A judicial warrant is a search warrant which gives any law enforcement offices free reign to investigate within the scope of the warrant. It will be signed by a judge. If the warrant is not signed by a judge, it will be an administrative warrant and that has limited authority.

Importantly, an administrative warrant allows you to request the enforcement officers come back later, especially if you are busy. Obviously, next year isn't going to be within the scope of "come back later," but at least it buys time to get your thoughts together and contact your lawyer.

Do you have I-9 forms stored where you can find them and are they organized? Also, try to contact another team member so you can share the anxiety.

Third, you might want lots of clarification on this, but my understanding is that ICE officers can only enter public areas of a farm with an administrative warrant.

Clear signage may be needed to define "public areas," and this is a simple thing you can do now, and it is also a good idea for biosecurity.

Drop Ship Reminders!

Raw Milk in the News

There is a major lawsuit in Florida alleging a child was hospitalized and a mother had a miscarriage from drinking raw milk that was sold to the family. A total of 21 people were sickened.

It is illegal to sell raw milk in Florida, which makes the sale an immediate liability to the farm and makes the lawsuit against the farmer that much harder to defend.

It is illegal in Wisconsin to sell raw milk, which makes it a huge liability. It is also important to recognize that selling raw milk, if it is illegal under state law, allows your insurance company to deny any coverage.

Lots of us drank raw milk out of bulk tanks for years. We are probably immune to the diseases we may have contracted. But food has fewer pathogens today and people in the city aren't exposed to all the disease that farmers and farm kids are exposed to.

You should probably think twice about selling or even serving raw milk to guests.
